I. Minutes:

IV. AD Report

There are 2 groups that switch due to the number of students. All sports are having students lift weights using the same techniques as showing by the strength and conditioning coach who will be also coaching.

V. Coach Discussions:

It was suggested that we meet twice a month and the committee agreed. A schedule was passed out for the upcoming school year.

VI. OLD BUSINESS:

a. Flag Fundraiser

July 4th is the next placement. We will continue to take checks with forms and transition to registering and paying through Iwantaflag.com. The spreadsheet should go to the treasurer. The routes are built on the website.

b. Spring Banquet Recap:

We collected \$800 - \$1000.

c. Ice cream Social:

This was not well attended. It was hot in the cafeteria and it was at the end of the school year when everyone was busy and get things wrapped up for the year. It needs to be scheduled earlier next year.

d. Social Media Update:

Ms. Collier needs to have important items included on the master email/eblast. Coach

Cripps will notify her. A flyer needs to be sent to Party on the Patio event in August. It was suggested coaches send out updates for each sport. Some coaches do this already, others are not using technology/social media. The suggestion is to cross post on Twitter/Facebook or let Tammy know and she will get it out. It was suggested to invite coaches to booster club meetings.
